PROVINCIAL RESOLUTION NO. 790-2024

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO SIGN THE DEED OF DONATION AND TO RECEIVE ONE (1) UNIT OF LAND AMBULANCE FROM THE DEPARTMENT OF HEALTH ILOCOS CENTER FOR HEALTH DEVELOPMENT

WHEREAS, one of the primordial concerns of the provincial government of Pangasinan is to address health issues and provide medical service needs of the people;

WHEREAS, the Department of Health (DOH), as the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities of local government units, has manifested its desire to further augment its support to the Provincial Government of Pangasinan through the Health Facility Enhancement Program;

WHEREAS, the Province of Pangasinan will be the recipient of one (1) unit of newly-equipped land ambulance amounting to P2,145,800.00 from the Department of Health Ilocos Center for Health Development in the form of a donation and hereby expresses its willingness to accept the same;

WHEREAS, this ambulance will be used primarily and effectively by the Province through the Manaoag Community Hospital to cater and respond immediately to the health necessities of the people especially in times of emergencies;

WHEREAS, it is to the best interest of the Provincial Government to sign the Deed of Donation and accept the ambulance from the Department of Health Ilocos Center for Health Development to augment the need for medical service vehicles of the Province;


