RESOLUTION NO. 791-2024

APPROVING RESOLUTION NO. 57, S-2024 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 1 CY 2024”

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 57, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Aguilar, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 1, CY 2024 of the LGU. This was endorsed by the Council, through MDC Resolution No. 1, S. 2024 dated May 27, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental AIP No. 1, CY 2024, which has a total investment requirement of ₱19,872,932.94, covers the augmentation of funds for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some LGU offices, and implementation of LDRRM projects/activities and other priority projects of the municipality; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 1, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2024 dated July 1, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Aguilar, Pangasinan;


