RESOLUTION NO. 793-2024

DECLARING ORDINANCE NO. 222, S-2023 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 222, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 129, 132 & 447 (3) (i) of R. A. No. 7160 and Section 11 (f) of R. A. No. 11032, otherwise known as "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services";

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 222, S-2023 of the Sangguniang Bayan of Basista, Pangasinan, entitled "An Ordinance on collection of corresponding barangay clearance fee in the application for any business-related transactions" as within the conferred powers of the Sangguniang Bayan to enact;
