RESOLUTION NO. 794-2024

DECLARING ORDINANCE NO. 223, S-2024 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE REVISING THE MUNICIPAL ORDINANCE NO. 82, S-2018, ENTITLED "AN ORDINANCE ENSURING EFFECTIVE AND EFFICIENT OPERATIONS AND MANAGEMENT OF THE EXISTING PUBLIC MARKET, SLAUGHTERHOUSE AND OTHER FACILITIES ATTACHED THERETO OF THE MUNICIPALITY OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 223, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 447 (3) (i) (iii) (5) (ii) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 of R.A. No. 7160;




