RESOLUTION NO. 796-2024

DECLARING ORDINANCE NO. 30, S-2024 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED “AN ORDINANCE REQUIRING ALL PRIMARY TOURISM ENTERPRISES TO SECURE ACCREDITATION FROM THE DEPARTMENT OF TOURISM PRIOR TO APPLICATION OF BUSINESS PERMIT, PROVIDING PENALTIES FOR VIOLATIONS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 30, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 39 & Rule 8, Chapter I, Section 122 (b) (4) of the Implementing Rules and Regulations of Republic Act No. 9593; and Sections 17 (a) (b) (2) (xi) & 447 (a) (i) (iii) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


