APPROVING RESOLUTION NO. 261, S-2024 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 1 CALENDAR YEAR 2024 OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 261, S- 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Mapandan, Pangasinan prepared the municipality's Supplemental Annual Investment Plan No. 1, CY 2024. This was endorsed by the Council, through MDC Resolution No. 2, S. 2024 dated May 17, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱10,782,968.46, covers the augmentation of funds for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices of the LGU, and implementation of LDRRM projects and other priority projects of the Municipality; and

3. Funding for the Supplemental AIP of the LGU is embodied in their Supplemental Budget No. 1, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, Series of 2024 dated June 3, 2024, and approved by Municipal Mayor on June 19, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mapandan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


