OF THE RESOLUTION NO. 268, S-2024 APPROVING MAPANDAN, PANGASINAN, SANGGUNIANG BAYAN OF AIP-SUPPLEMENTAL **"APPROVING** THE 2024 ENTITLED INVESTMENT PLAN (SIP) NO. 2 OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN AMOUNTING TO TWENTY-EIGHT MILLION EIGHT HUNDRED THOUSAND PESOS (P28,800,000.00) ONLY"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 268, S- 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Mapandan, Pangasinan prepared the municipality's Supplemental Investment Plan No. 2, CY 2024. This was endorsed by the Council, through MDC Resolution No. 03, S. 2024 dated June 13, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental Investment Program, which has a total investment requirement of ₱28,800,000.00, covers the procurement of 16 units of Manual Transmission Rescue Vehicles for the LGU and its 15 barangays; and

3. Funding for the Supplemental AIP will be sourced from the proposed loan of the LGU from the Land Bank of the Philippines.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mapandan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 268, S-2024 of the Sangguniang Bayan of Mapandan, Pangasinan, entitled "Approving the 2024 AIP-Supplemental Investment Plan (SIP) No. 2 of the Municipality of Mapandan, Province of Pangasinan amounting to twenty-eight million eight hundred thousand pesos (P28,800,000.00) only";
