APPROVING RESOLUTION NO. 2024-045 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) PURSUANT TO APPROPRIATION ORDINANCE NO. 2024-001 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF EIGHTEEN MILLION THREE HUNDRED FIFTY FOUR THOUSAND EIGHT HUNDRED TWENTY TWO PESOS AND 15/100 (P18,354,822.15)”

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2024-045 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Tayug, Pangasinan has identified items in their Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan on June 21, 2024 through MDC Resolution No. 2024-02;
2. The SAIP of the municipality covers augmentation of fund for Personal Services, Maintenance and Other Operating Expenses and implementation of development projects of LGU Tayug; and

3. Funding support for the implementation of SAIP No.1, with a total investment requirement of PhP18,354,822.15 is embodied in the municipality's Supplemental Budget No.1, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-001 on July 1, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Tayug, Pangasinan;


