**PROVINCIAL RESOLUTION NO. 812-2024**

**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM  
NO. 4 OF THE PROVINCE OF PANGASINAN FOR CALENDAR  
YEAR 2024**

**WHEREAS**, presented for consideration is the Supplemental Investment Program No. 4 of the Province of Pangasinan for Calendar Year 2024 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 06-24;

**WHEREAS**, Supplemental Investment Program No. 4 contains other priority programs, projects and activities that were not included in the approved 2024 Annual/Supplemental Investment Program of the Province of Pangasinan;

**WHEREAS**, programs and projects included in the said Supplemental Investment Program covers the Construction of Eleven (11) Storey Government Center and the Redevelopment of the Capitol Complex including the rehabilitation of road network, construction of multi-purpose facility, community park center and other facilities (Phase II) to be financed from the loan proceeds with the Land Bank of the Philippines;

**WHEREAS**, the Supplemental Investment Program covers the revised/refined programs, projects and activities of Provincial Health Office and Pangasinan Polytechnic College as embodied in the Annual Investment Program CY 2024 to accommodate changes in the expected output but with no changes in the total financial requirement;

**WHEREAS**, also included in the said Supplemental Investment Program is the fund augmentation for Personal Services to implement the salary increase of civilian government personnel pursuant to Executive Order No. 64, Series of 2024, issued by the Office of the President as well as the implementation of various infrastructure support projects;

**WHEREAS**, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;

**NOW, THEREFORE**, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


