DECLARING ORDINANCE NO. 2024-17 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE TEMPORARILY SUSPENDING THE IMPOSITION OF PENALTY ON WEARING OF SLIPPERS AND SHORTS BY TRICYCLE DRIVERS IN THE CITY DULY PROVIDED UNDER ARTICLE XXV (1) OF CITY ORDINANCE NO. 2021-13, OTHERWISE KNOWN AS "THE 2021 AMENDMENT TO THE TRAFFIC CODE" OF THE CITY OF ALAMINOS, PANGASINAN, FROM 28 JUNE 2024 TO 04 NOVEMBER 2024" AS WITIHN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2024-17 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (a) of R.A. No. 7160;
