## **RESOLUTION NO. 817-2024**

DECLARING ORDINANCE NO. 2024-18 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE INSTALLATION AND USE OF BOOSTER PUMPS WITHIN THE CITY OF ALAMINOS, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2024-18 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16, 17 and 458 (a) (1) (iii) (5) (vii) of R.A. No. 7160; The Philippine Clean Water Act of 2004 (R.A. No. 9275);

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
