**APPROVING RESOLUTION NO. 2024-138 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2, C.Y. 2024 OF SUAL, PANGASINAN AMOUNTING TO FORTY-FOUR MILLION FOUR HUNDRED EIGHTY-NINE THOUSAND EIGHT HUNDRED TWO & 45/100 PESOS (P44,489,802.45)”**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2024-138 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 2 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on May 21, 2024 by the Municipal Development Council through Resolution No. 3, Series of 2024;
2. The SIP No. 2 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal government offices, and the implementation of various disaster risk reduction and management programs/projects of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP44,489,802.45 is embodied in their proposed Supplemental Budget No. 02, CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03, CY 2024 on June 3, 2024.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;


