#### **RESOLUTION NO. 820-2024**

APPROVING RESOLUTION NO. 258, S-2023 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 258-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Urbiztondo, Pangasinan prepared their Supplemental Investment Program (SIP) No. 5 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 08, S' 2023 dated December 21, 2023, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental Investment Program, which has a total investment requirement of ₱3,375,091.23, covers the augmentation of funds for Maintenance and Other Operating Expenses (MOOE) of some municipal offices of the LGU, and implementation of LDRRM programs/activities, and other priority projects of the municipality; and

3. Funding for the full implementation of the Supplemental Investment Program is embodied in the LGU's Supplemental Budget No. 05 for FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 6-2023 dated December 22, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo, Pangasinan;
