#### **RESOLUTION NO. 824-2024**

DECLARING MUNICIPAL ORDINANCE NO. 2024-02 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE DISPENSING, SELLING AND RESELLING OF PHARMACEUTICAL PRODUCTS IN SARI-SARI STORES AND OTHER SIMILAR RETAIL OUTLETS IN THE MUNICIPALITY OF BALUNGAO, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2024-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 447 (a) (1) (iii) of R. A. No. 7160; R. A. No.10918, otherwise known as the "Philippine Pharmacy Act"; R.A. No. 9711 or the "Food and Drug Administration Act of 2009"; and Section 15 Article II of the 1987 Philippine Constitution;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
