**RESOLUTION NO. 825-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 2024-03 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE MUNICIPALITY’S CODE ON SLAUGHTERHOUSE AND MEAT INSPECTION, APPROPRIATION OF FUNDS, COLLECTION OF FEES AND CHARGES AND IMPOSITION OF PENALTIES FOR VIOLATIONS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2024-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 447 (3) (i) (5), 129 and 132 of R. A. No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2024-03 of the Sangguniang Bayan of Balungao, Pangasinan, entitled “An Ordinance enacting the Municipality’s Code on Slaughterhouse and Meat Inspection, appropriation of funds, collection of fees and charges and imposition of penalties for violations thereof” as within the conferred powers of the Sangguniang Bayan to enact;


