#### PROVINCIAL RESOLUTION NO. 832-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – ILOCOS CENTER FOR HEALTH DEVELOPMENT I FOR THE IMPLEMENTATION OF THE HEALTH FACILITIES ENHANCEMENT PROGRAM ANENT THE REPAIR OF THE PANGASINAN PROVINCIAL HOSPITAL

WHEREAS, the Department of Health (DOH) is the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities and has manifested its desire to further augment its support to the Provincial Government of Pangasinan's health care program through the Health Facilities Enhancement Program (HFEP);

WHEREAS, the HFEP serves as the national government's vehicle by which public health care facilities receive assistance for infrastructure improvement and equipment upgrade;

**WHEREAS,** the Department of Health through the Health Emergency Management Bureau has appropriated an amount of P2,000,000.00 for the repair of the Pangasinan Provincial Hospital which shall be transferred to the Provincial Government of Pangasinan;

WHEREAS, it is in the best interest of the Provincial Government of Pangasinan, represented by Governor Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Department of Health-Center for Health Development I, represented by Dr. Paula Paz M. Sydiongco, Regional Director;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;
