**PROVINCIAL RESOLUTION NO. 833-2024**

**AUTHORIZING THE LAND BANK OF THE PHILIPPINES-LINGAYEN BRANCH TO REACTIVATE A DORMANT ACCOUNT OF THE PROVINCIAL GOVERNMENT OF PANGASINAN AND FURTHER AUTHORIZING THE PROVINCIAL GOVERNOR AND THE PROVINCIAL TREASURER TO EXECUTE AND SIGN ALL PERTINENT DOCUMENTS THEREOF**

**WHEREAS**, LANDBANK records show that there is a deposit account under the name of the Provincial Government of Pangasinan which has been classified as “Dormant” status;

**WHEREAS**, the Provincial Government of Pangasinan still needs to maintain the said account for its financial transactions;

**WHEREAS**, it is necessary therefore to request the reactivation of Account Number 2422-1078-89 bearing the Account Name of the Province of Pangasinan Special Health Fund;

**WHEREFORE**, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the Land Bank of the Philippines-Lingayen Branch to reactivate a dormant account of the Provincial Government of Pangasinan and further authorizing the Provincial Governor and the Provincial Treasurer to execute and sign all pertinent documents thereof;


