**PROVINCIAL RESOLUTION NO. 834-2024**

**AUTHORIZING THE GOVERNOR, HONORABLE RAMON V. GUICO III, TO APPLY FOR THE ACCREDITATION OF PANGASINAN PROVINCIAL HOSPITAL AS A LEVEL III HEALTHCARE FACILITY WITH THE DEPARTMENT OF HEALTH**

**WHEREAS**, the Pangasinan Provincial Hospital located in San Carlos City, Pangasinan, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities of the 3<sup>rd</sup> District of Pangasinan as well as other neighboring municipalities;

**WHEREAS**, at present, there is a significant increase in the number of patients being serviced by the hospital and there is a need to accommodate all the patients availing of the services of the Pangasinan Provincial Hospital and provide them the best quality healthcare services;

**WHEREAS**, the Pangasinan Provincial Hospital is currently classified as a Level II Hospital here in Pangasinan with authorized bed capacity of 250;

**WHEREAS**, the Provincial Government of Pangasinan intends to put up or establish a Level III Hospital or a Tertiary Hospital through the Pangasinan Provincial Hospital;

**WHEREAS**, with the establishment of a Level III hospital which includes all of Level I and Level II services, plus among others, a teaching or training program, the Provincial Government of Pangasinan may cater to internship or on-the-job training of students taking up medical related concerns and eventually pave the way for the establishment of a School of Medicine attached to or within the Pangasinan Polytechnic College;

**WHEREAS**, in addition to the above paragraph, a Level III Hospital also requires a physical medicine and rehabilitation unit, ambulatory surgical clinic, dialysis unit, tertiary clinical laboratory with hispathology, blood bank, and third level x-ray, among others, wherein with these wide variety of facilities or interventions more patients could be catered within and outside Pangasinan;

**WHEREFORE**, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Governor, Honorable Ramon V. Guico III, to apply for the accreditation of Pangasinan Provincial Hospital as a Level III Healthcare Facility with the Department of Health and grant such other powers necessary, appropriate or incidental to the said application;

**RESOLVED, FINALLY**, that copies of this resolution be furnished to the Secretary of the Department of Health, for its appropriate action; Honorable Ramon V. Guico III, Provincial Governor; Dr. Cipriano C. Fernandez, Chief of Hospital, Pangasinan Provincial Hospital; and the Provincial Hospital Management Services Office, for their information, reference and guidance.
