PROVINCIAL RESOLUTION NO. 841-2024

INTERPOSING NO OBJECTION TO AND ENDORSING THE DEVELOPMENT AND OPERATION OF BUGALLON SOLAR POWER PROJECT OF THE IXUS SOLAR ENERGY CORP., A VENA ENERGY COMPANY, LOCATED IN BUGALLON, PANGASINAN

WHEREAS, Ixus Solar Energy Corp., a Vena Energy company, is undertaking the development of a solar energy plant of up to 550 MWp with an attached energy storage plant of up to 200 MW at its identified project site located within Bugallon, Pangasinan;

WHEREAS, Ixus Solar Energy Corp., in its letter dated August 27, 2024, through its authorized representative, Mr. Westin Raymond A. Contreras, has requested the Sangguniang Panlalawigan, through the Provincial Vice Governor, Mark Ronald DG. Lambino, for the enactment of a resolution endorsing the project, with no objection;

WHEREAS, the Department of Energy has granted Ixus Solar Energy Corp. a Solar Energy Operating Contract (SEOC) No. 2023-09-703 on October 3, 2023 to explore, develop and utilize solar resources within the contract area in Bugallon, Pangasinan;

WHEREAS, the establishment of an alternative source of power is a welcome development in the Province of Pangasinan considering the present high cost of energy in the country;

WHEREAS, subject to compliance with pertinent laws, existing rules, regulations and ordinances appurtenant to the implementation of the Bugallon Solar Power Project, the Sangguniang Panlalawigan interposes no objection to the request and consequently endorses the same;

WHEREAS, RA 9513, otherwise known as Renewable Energy Act of 2008 provides for the acceleration and encouragement for the exploration, development and utilization of renewable energy resources in the country;

NOW, THEREFORE, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco, duly seconded, it was –


