**APPROVING RESOLUTION NO. 380, S-2024 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1 FOR CY 2024 OF BASISTA, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Resolution No. 380, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Basista, Pangasinan prepared their Supplemental Investment Program (SIP) No. 1 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 1, Series of 2024 dated June 27, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱10,034,486.20, covers the augmentation of funds for MOOE and Capital Outlay of some municipal offices, and implementation of LDRRM projects/activities and development projects of the LGU; and

- The projects proposed to be funded from the reversion of the 20% Development Fund conform with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects.


