#### **RESOLUTION NO. 849-2024**

APPROVING RESOLUTION NO. 2024-376 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2024-04 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2024, REQUIRING A TOTAL FUNDING OF ONE MILLION EIGHT HUNDRED THOUSAND PESOS (P1,800,000.00)"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2024-376 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 2024-04, CY 2024. This was endorsed by the Council, through MDC Resolution No. 2024-05, Series of 2024 dated June 28, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental AIP, which has an investment requirement of ₱1,800,000.00, covers the implementation of the project: Concreting of Barangay Road (Sitio Riverside) in Barangay Maningding, Sta. Barbara; and

3. Funding for the Supplemental AIP will be sourced from the Seal of Good Local Governance Incentive Fund of the Department of Interior and Local Government.
