#### **RESOLUTION NO. 850-2024**

#### APPROVING RESOLUTION NO. 24-088 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 5 FOR CALENDAR YEAR 2024 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 24-088 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The City Development Council of San Carlos City, Pangasinan prepared the Supplemental Investment Program (SIP) No. 5, CY 2024. This was endorsed by the Council, through CDC ExeCom Resolution No. 06-24 (Series of 2024) dated June 18, 2024, to the Sangguniang Panlungsod for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- The Supplemental Investment Program (SIP), which has a total investment requirement of ₱168,910,000.00, covers the augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOEs) and Capital Outlay (CO) of various offices of the City Government, and implementation of priority projects of the LGU; and

3. Funding support for the implementation of the SIP is embodied in the LGU's Supplemental Budget No. 03-24, FY 2024, which was enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 24-13 dated June 24, 2024 and approved by the Acting City Mayor on June 24,2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of San Carlos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-
