RESOLUTION NO. 853-2024

DECLARING ORDINANCE NO. 1, S-2024 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, AN ORDINANCE ESTABLISHING MUNICIPAL SCHOLARSHIP PROGRAM IN THE MUNICIPALITY OF SAN FABIAN, PANGASINAN, AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 1, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 17 (a) (2) (iv) 447(a)(5)(xi) of R.A. No. 7160; Republic Act No. 109311 otherwise known as "Universal Access to Quality Tertiary Education Act"; Republic Act No. 10648 entitled: "An Act Providing Scholarship Grants to Top Graduates of All Public High Schools in State Universities and Colleges and appropriating funds therefor"; and Article II, Section 17 and Article XIV, Section 1 of the 1987 Philippine Constitution;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 01, S-2024 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled "An Ordinance establishing Municipal Scholarship Program in the Municipality of San Fabian, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
