**RESOLUTION NO. 855-2024**

**DECLARING ORDINANCE NO. 2024-02 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING MECHANISMS FOR THE IMPLEMENTATION OF REPUBLIC ACT NO. 9208 OR THE “ANTI-TRAFFICKING IN PERSONS ACT OF 2003” AND FOR SUCH OTHER PURPOSES IN THE MUNICIPALITY OF SISON, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Ordinance No. 2024-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Republic Act No. 10364 “Expanded Anti-Trafficking in Persons Act” and Section 16 and Section 17(b) (2) (iii) (iv) and (5) (xiv) of the Local Government Code of 1991;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2024-02 of the Sangguniang Bayan of Sison, Pangasinan, entitled “An Ordinance establishing mechanisms for the implementation of Republic Act No. 9208 or the “Anti-Trafficking in Persons Act of 2003” and for such other purposes in the Municipality of Sison, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
