RESOLUTION NO. 857-2024

DECLARING SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2024 OF SAN MANUEL, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P10,568,400.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Supplemental Budget No. 3 for CY 2024 involving total appropriations of P10,568,400.00, which was enacted on June 26, 2024 through Appropriation Ordinance No. 03, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all programs, projects and activities to be implemented are in accordance with the approved CY 2024 Annual Investment Program of the Municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF JMC No. 1, Series of 2007 dated March 8, 2007;

3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
4. That the grant of increase in Representation & Transportation Allowances (RATA) shall be in accordance to the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management; and
5. That the procurement of transportation equipment shall be in accordance with the provisions of DBM Budget Circular No. 2022-1 dated February 11, 2022 (Omnibus Guidelines on the Acquisition, Use, Rental, & Replacement of Government Motor Vehicles) and Budget Circular No. 2022-1A dated March 1, 2023 (Supplemental Guidelines on the Acquisition, Use, Rental, & Replacement of Government Motor Vehicles).

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan., duly seconded, it was—


