APPROVING SB RESOLUTION NO. 36, S-2024 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 FY 2024 OF THE MUNICIPALITY OF BANI, PANGASINAN AMOUNTING TO EIGHT MILLION, THREE HUNDRED SIXTEEN THOUSAND, TWO HUNDRED TWO PESOS AND FORTY-FOUR CENTAVOS (P8,316,202.44) FUNDED FROM THE REALIGNED/REVERTED FY 2024 GENERAL FUND SPECIAL PURPOSE APPROPRIATION, MDF 2024, 2023, 2022, 2021 & 2017 AND SAVINGS FROM PERSONAL SERVICES FY 2024"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 36, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

 In consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991, the Local Development Council of Bani, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 1 CY 2024. This was endorsed to the Sangguniang Bayan on June 26, 2024 through MDC Resolution No. 2024-03 and was favorably acted upon by the Sangguniang Bayan on July 15, 2024;

- The SIP No. 01 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some municipal offices, and implementation of priority programs/projects of the LGU. It has a total investment requirement of PhP8,316,202.44; and
- Funds for the purpose amounting to PhP8,316,202.44 is embodied in the municipality's Supplemental Budget No. 01 FY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No.01-S.2024 on July 15, 2024 and approved by the Municipal Mayor on July 22, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 36, S-2024 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving the Supplemental Annual Investment Program No. 01 FY 2024 of the Municipality of Bani, Pangasinan amounting to eight million, three hundred sixteen thousand, two hundred two pesos and forty-four centavos (P8,316,202.44) funded from the realigned/reverted FY 2024 General Fund Special Purpose Appropriation, MDF 2024, 2023, 2022, 2021 & 2017 and savings from personal services FY 2024";

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bani, Pangasinan, for its information and guidance.
