#### **RESOLUTION NO. 863-2024**

APPROVING RESOLUTION NO. 75, S-2024 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL AIP NO. 2, CY 2024 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF P7,270,719.81 FROM THE GENERAL FUND FOR THE IMPLEMENTATION OF VARIOUS MUNICIPAL PROJECTS FOR THE OPERATION OF THE LOCAL GOVERNMENT OF SAN FABIAN, PROVIDING APPROPRIATIONS THEREOF"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 75, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Annual Investment Program (SAIP) No. 2 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 03-S. 2024 dated June 6, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental AIP, which has an investment requirement of P7,270,719.81, covers the augmentation of funds for Personal Services, Maintenance and Other Operating Expenses (MOOE) and Capital Outlay of some municipal offices, and implementation of LDRRM projects/activities and various development projects of the LGU;

- 3. The project proposed to be funded from the reversion of the 20% Development Fund in the amount of P719,925.99, conforms with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects. Also, the proposed projects/activities to be funded from the 5% LDRRM Fund are based on the Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);
- 4. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 2 for CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2, S-2024 dated July 10, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Fabian, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 75, S-2024 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled "Approving the Supplemental AIP No. 2, CY 2024 of the Local Government of San Fabian, Pangasinan in the amount of P7,270,719.81 from the General Fund for the implementation of various municipal projects for the operation of the Local Government of San Fabian, providing appropriations thereof";
