RESOLUTION NO. 864-2024

DECLARING SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2024 OF SAN FABIAN, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P7,270,719.81, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Supplemental Budget No. 2 for CY 2024 involving total appropriations of P7,270,719.81, which was enacted on July 10, 2024 through Appropriation Ordinance No. 2, S-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the implementation of the increase in Representation and Transportation Allowances (RATA) shall be in accordance with the Local Budget Circular No. 157 dated May 03, 2024;
2. That the disbursement of appropriation for Service Recognition Incentive shall be in accordance with the guidelines granting the same;
3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;

4. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007; and
6. That the disbursement of additional One Thousand Pesos P1,000.00) in Uniform/Clothing Allowance shall be in accordance with Budget Circular No. 2024-1 dated April 4, 2024.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


