APPROVING RESOLUTION NO. 75-2024 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Resolution No. 75-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Burgos, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No.1 CY 2024. This was endorsed to the Sangguniang Bayan on May 9, 2024 through MDC Resolution No.2024-02;
- 2. Said SAIP No. 1 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some municipal offices, and the implementation of various development programs/projects of the LGU; and

3. The proposed SAIP has a total investment requirement of PhP24,582,203.40. Funding support for the implementation of such is embodied in the municipality's Supplemental Budget No.01 FY 2024 amounting to Php11,248,869.40, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No.01-2024 on June 13, 2024. The remaining amount equivalent to PhP13,333,334.00, which will fund the Construction of Level III Water Supply @ Brgy. Concordia, will be sourced out from the LGSF-Support and Assistance Fund to Participatory Budgeting (SAFPD) which the LGU of Burgos is one of the recipients. The project is in accordance with DBM and DILG JMC No.1, Series of 2024 (Policy Guidelines and Procedures in the Implementation of the Local Government Support Fund – Support and Assistance Fund to Participatory Budgeting (LGSF-SAFPB) under the FY 2024 General Appropriations Act (GAA), RA 11975.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Burgos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 75-2024 of the Sangguniang Bayan of Burgos, Pangasinan, entitled "Approving the Supplemental Annual Investment Program No. 1 for Calendar Year 2024 of the Municipality of Burgos, Province of Pangasinan";
