DECLARING ORDINANCE NO. 04, S-2024 OF THE SANGGUNIANG PANGASINAN, ENTITLED OF INFANTA, BAYAN CASH INCENTIVE **MONTHLY ORDINANCE PROVIDING** (SUBSISTENCE ALLOWANCE) TO BARANGAY WORKERS (BHW), BARANGAY NUTRITION SCHOLARS (BNS) AND BARANGAY POPULATION WORKERS (BPW) IN THE MUNICIPALITY OF INFANTA, PANGASINAN AMOUNTING TO ONE THOUSAND PESOS (P1,000.00)" WITHIN AS CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 04, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (2) (iv) & 447 (a) (1) (5) (viii) (xiv) of R.A. No. 7160;

WHEREAS, the Local Chief Executive in coordination with the Municipal Local Finance Committee shall provide a supplemental appropriation for the implementation of the subject ordinance and a Certification as to availability of funds shall be submitted to the Sangguniang Panlalawigan;
