RESOLUTION NO. 883-2024

DECLARING MUNICIPAL ORDINANCE NO. 2024-01 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT, DEVELOPMENT, CONSERVATION, AND MAINTENANCE OF MUNICIPAL PARKS AND GREEN SPACES SUCH AS PUBLIC PARKS, PLAZAS, AND OPEN SPACES DEVOTED FOR PUBLIC USE, REGULATING THEIR USE, AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2024-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 447 (a) (1) (5) & (v) of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


