PROVINCIAL RESOLUTION NO. 888-2024

APPROVING AND ADOPTING AS ITS DECISION EN BANC, THE ORDER OF THE COMMITTEE ON GOOD GOVERNMENT AND ACCOUNTABILITY OF PUBLIC OFFICERS, JUSTICE AND HUMAN RIGHTS (CGGAPOJHR) DENYING THE MOTION FOR RECONSIDERATION IN SP ADMINISTRATIVE CASE NO 01-2024

WHEREAS, on August 20, 2024, the Sangguniang Panlalawigan was in receipt of a Motion for Reconsideration re Provincial Resolution No. 703-2024 of SP Administrative Case No. 01-2024, entitled, Punong Barangay Rey G. Velarde, Respondent-Appellant versus Josephine C. Damasco, Complainant-Appellee for Abuse of Authority, Oppression, Grave Misconduct and Neglect of Duty;

WHEREAS, after a careful study on the merits of the said Motion, the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights submitted its Order which was adopted as Committee Report No. 41-2024 in its Regular Session on September 23, 2024, to wit;

ORDER

THIS IS TO RESOLVE the Motion for Reconsideration on the Decision rendered by the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights embodied in Provincial Resolution No. 703-2024, filed by the complainant-appellee through counsel, praying that said Decision be reconsidered/set aside.

Considering that the contentions in the Motion for Reconsideration have been sufficiently passed upon and clearly addressed in the recommendation of the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights which is the basis of Provincial Resolution No. 703-2024, the Committee finds no cogent reason to reconsider/set aside its earlier recommendation as adopted in Provincial Resolution No. 703-2024, which set aside and reversed the Decision of the Sangguniang Bayan of Tayug, Pangasinan.
