PROVINCIAL RESOLUTION NO. 922-2024

**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM
NO. 5 OF THE PROVINCE OF PANGASINAN FOR CALENDAR
YEAR 2024**

WHEREAS, presented for consideration is the Supplemental Investment Program No. 5 of the Province of Pangasinan for Calendar Year 2024 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 08-24;

WHEREAS, Supplemental Investment Program No. 5 contains other priority programs, projects and activities that were not included in the approved 2024 Annual/Supplemental Investment Program of the Province of Pangasinan;

WHEREAS, the programs and projects included in the said Supplemental Investment Program covers the implementation of the Pangasinan Government Unified Incentives for Medical Consultations Program or GUICONSULTA, which is in pursuance to the provisions of the Universal Health Care Act and Philhealth Konsulta with the aim to promote preventive health care for every Pangasinense, especially the underprivileged;

WHEREAS, said Supplemental Investment Program also includes gender and development programs, local risk reduction project and augmentation of funds for some of the priority projects of the province;

WHEREAS, also embodied in the program is the Construction of Umingan District Hospital with Site Development (Phase II), construction of facilities in various hospitals of the Province and construction of Farm-To-Market Road in San Manuel, Pangasinan, which are proposed to be funded from the share of the Province from the 2021 Excise Tax collection;

WHEREAS, said Supplemental Investment Program also covers the Construction of Cabalaoangan Bridge #2 in Rosales, Pangasinan and the Construction of Farm-To-Market Road in Sta. Maria, Pangasinan, which are proposed for funding from the Department of Agrarian Reform;

NOW, THEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


