PROVINCIAL RESOLUTION NO. 923-2024

ENDORSING TO THE PHILIPPINE REGISTRY OF HERITAGE THROUGH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS THE UPDATED INVENTORY OF CULTURAL PROPERTIES/HISTORICAL LANDMARKS UNDER THE DIRECT CARE AND SUPERVISION OF THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, physical or tangible and intangible cultural heritage includes buildings, World War II memorabilia and other works of art, and also festival celebration depicting the history of the Province are worthy of protection and preservation by the Provincial Government of Pangasinan;

WHEREAS, Republic Act No. 11961, is an Act Strengthening the Conservation and Protection of Philippine Cultural Heritage through Cultural Mapping and Enhanced Cultural Heritage Education Program, amending for the Purpose Republic Act No. 10066, otherwise known as the "National Cultural Heritage Act of 2009";

WHEREAS, Section 14 thereof mandates Local Government Units (LGUs) to maintain an inventory of their cultural properties and submit the same to the National Commission for Culture and the Arts to form part of the Philippine Registry of Heritage or PRH (formerly Philippine Registry of Cultural Properties or PRECUP);

WHEREAS, the Provincial Government of Pangasinan has been maintaining and updating an inventory, evaluating, and documenting all its cultural properties and historical landmarks;

WHEREAS, the Provincial Tourism and Cultural Affairs Office has submitted to the Sangguniang Panlalawigan an updated list of official inventory of cultural properties/historical landmarks under the direct care and supervision of the Provincial Government of Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Marinor B. de Guzman, duly seconded, it was –


