## **PROVINCIAL RESOLUTION NO. 924-2024**

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BETWEEN AND AMONG PV SINAG POWER, INC. AND ABOITIZ FOUNDATION, INC. FOR THE DONATION OF P700,000.00 WORTH OF MEDICINES TO BE DISTRIBUTED AMONG THE THREE (3) IDENTIFIED DISTRICT HOSPITALS IN THE PROVINCE OF PANGASINAN

WHEREAS, PV Sinag Power, Inc. is a subsidiary company of Aboitiz Power Corporation which is engaged in power distribution, generation and retail electricity services based in the Philippines;

WHEREAS, the Aboitiz Foundation, Inc. is the social development arm of the Aboitiz Group responsible for focusing on the corporate social responsibility (CSR) efforts of the Aboitiz Group to ensure that proper and worthwhile CSR projects and activities are identified as well as to locate the appropriate beneficiaries therefore;

WHEREAS, as part of the mandate of corporate social responsibility, PV Sinag Power, Inc. and the Aboitiz Foundation, Inc. are committed to contributing to the wellbeing of communities and society through various environmental, health and social measures;

**WHEREAS**, PV Sinag Power, Inc. and the Aboitiz Foundation, Inc. will donate P700,000.00 worth of medicines to be distributed among the three (3) identified district hospitals in the Province of Pangasinan;

WHEREAS, this donation can be utilized by the Provincial Government of Pangasinan to further enhance the delivery of public health care services;

WHEREAS, this measure granting authority to the Honorable Governor to enter into a Memorandum of Agreement between and among PV Sinag Power, Inc. and Aboitiz Foundation, Inc. is anchored on Sections 22 (a) (5) (c) and Section 465 (vi) of the Local Government Code of 1991;

WHEREAS, for the above purpose, the Memorandum of Agreement shall be entered into and signed between and among the Province of Pangasinan, represented by Governor Ramon V. Guico III; the PV Sinag Power, Inc., represented by its Vice President and Chief Operating Officer, Mr. Rolando G. Pacquiao; and the Aboitiz Foundation, Inc., represented by its Chief Operating Officer, Ms. Maria Remedios Dominique Mapa-Suplido;

WHEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was -

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) between and among PV Sinag Power, Inc. and Aboitiz Foundation, Inc. for the donation of P700,000.00 worth of medicines to be distributed among the three (3) identified District Hospitals in the Province of Pangasinan;
