PROVINCIAL RESOLUTION NO. 925-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL POLICE COMMISSION (NAPOLCOM) FOR THE GRANT OF ASSISTANCE IN THE CONDUCT OF NAPOLCOM EXAMINATION IN THE PROVINCE OF PANGASINAN

WHEREAS, Section 22 of Republic Act No. 6975 as amended, the National Police Commission (NAPOLCOM) is mandated to conduct PNP Entrance and Promotional Examinations for civilians desiring to enter the police service and uniformed personnel of the Philippine National Police, respectively;

WHEREAS, said examinations are conducted twice a year nationwide by the NAPOLCOM;

WHEREAS, based on recent statistics pertaining to past NAPOLCOM examination in Region I, the bulk or more or less 60% of the total number of examinees come from the Province of Pangasinan and many are forced to travel from Pangasinan to San Fernando City, La Union;

WHEREAS, the NAPOLCOM in collaboration with the Provincial Government of Pangasinan will conduct the PNP Entrance and Promotional Examinations in Pangasinan on November 24, 2024 for examinees who are residents of the Province;

WHEREAS, the Provincial Government of Pangasinan has committed to support the conduct of NAPOLCOM examinations in Pangasinan through the grant of assistance of not more than Five Hundred Seventy-Eight Thousand Two Hundred Pesos (P578,200.00), subject to the usual auditing and accounting rules;

WHEREAS, the Provincial Government of Pangasinan fully supports this noble undertaking in the conduct of the NAPOLCOM examinations in the Province in order to further enhance the needed services of the people especially those who will be taking the upcoming examinations in terms of saving their precious time, effort and money;

WHEREAS, Section 23 of RA 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives may, upon authority of the sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefor from any department, agency, or office of the national government or from any higher local government unit;

WHEREAS, likewise, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (b) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;


WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the NAPOLCOM, represented by the Vice Chairperson and Executive Officer Alberto A. Bernardo;

NOW, THEREFORE, on motion of SP Member Raul R. Sabangan, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the National Police Commission (NAPOLCOM) for the grant of assistance in the conduct of NAPOLCOM Examination in the Province of Pangasinan;
