RESOLUTION NO. 930-2024

APPROVING SB RESOLUTION NO. 138-2024 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “APPROVING THE 2ND SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its SB Resolution No. 138-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Manaoag, Pangasinan prepared the municipality’s 2nd Supplemental Investment Program for CY 2024. This was endorsed by the Council, through MDC Resolution No.02, Series of 2024 dated June 11, 2024, to the Sangguniang Bayan for approval;
2. The Sangguniang Bayan approved said Supplemental Investment Program through SB Resolution No. 138-2024 dated June 25, 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;

3. Said Supplemental Investment Program (SIP), which has an investment requirement of ₱29,761,472.80, covers augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expense (MOOE) and Capital Outlay (CO) of some municipal offices of the LGU, and implementation of LDRRM projects/activities, agri-infra support projects, and other development projects of the municipality;
4. The projects/activities proposed to be funded from the 20% Development Fund and 5% LDRRM Fund conform with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects) and Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund), respectively. Likewise, the proposed projects to be funded from the Tobacco Excise Tax Share of the LGU and Local Government Support Fund-Financial Assistance to LGUs, FY 2024 are based on Local Budget Memorandum No. 89 dated November 10, 2023, of the Department of Budget and Management and Local Budget Circular No. 155 dated February 15, 2024 (Guidelines on the Release and Utilization of the Local Government Support Fund-Financial Assistance to Local Government Units under the FY-2024 General Appropriations Act, Republic Act No. 11975), respectively; and
5. Funding for the SIP is embodied in the LGU's Supplemental Budget No. 2, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02, Series of 2024 dated July 2, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Manaoag, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 138-2024 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled “Approving the 2nd Supplemental Investment Program for Calendar Year 2024 of the municipality of Manaoag, Pangasinan”;


