**RESOLUTION NO. 931-2024**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2024 OF MANAOAG, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P29,761,472.80, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Supplemental Budget No. 2 for CY 2024 involving total appropriations of P29,761,472.80, which was enacted on July 2, 2024 through Appropriation Ordinance No. 2, Series of 2024;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all programs, projects and activities to be implemented are in accordance with the approved CY 2024 Annual Investment Program of the Municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF JMC No. 1, Series of 2007 dated March 8, 2007;

3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
4. That the utilization of appropriations from shares of the Municipality from Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum No. 89 dated November 10, 2023;
5. That the utilization of appropriations from the Local Government Support Fund shall be subject to the provisions of Local Budget Memorandum No. 155 (Guidelines on the Release and Utilization of the Local Government Support Fund-Financial Assistance to Local Government Units under the FY 2024 General Appropriations Act, Republic Act No. 11975) dated February 15, 2024;
6. That the grant of increase in Representation & Transportation Allowances (RATA) shall be in accordance to the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management; and
7. That the appropriation for the additional employer (government) share in the premium contributions to the Home Development Mutual Fund (PAG-IBIG FUND) shall be in accordance to DBM Circular Letter No. 2024-2 dated February 1, 2024.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 2 for Calendar Year 2024 of Manaoag, Pangasinan;


