APPROVING RESOLUTION NO. 265-08142024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE (2nd) SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2024 FUNDED BY THE UNAPPROPRIATED SURPLUS (EXCESS INCOME), AND REVERSION OF APPROPRIATIONS FOR ABOLISHED POSITIONS OF LGU POZORRUBIO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 265-08142024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Pozorrubio, Pangasinan has identified items in their Supplemental Annual Investment Program No. 2. This was endorsed to the Sangguniang Bayan for approval on July 15, 2024 by the Municipal Development Council through Resolution 02 Series 2024 and was favorably acted upon by the Sangguniang Bayan on August 14, 2024 through Resolution No. 265-08142024;
2. The SAIP covers fund augmentation for the Personal Services and implementation of Local Disaster Risk Reduction Management programs and projects of the LGU; and

3. Funding support for the full implementation of the same in the amount of Php 4,968,130.74 is embodied in their Supplemental Budget No. 2 for CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02-08142024 on August 14, 2024 and approved by the Municipal Mayor on August 19, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Pozorrubio, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


