RESOLUTION NO. 936-2024

APPROVING RESOLUTION NO. 444, S-2022-25 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1 OF THE CITY OF URDANETA FOR CY 2024 IN THE AMOUNT OF TWELVE MILLION EIGHT HUNDRED SEVENTY-TWO THOUSAND ONE HUNDRED EIGHTY PESOS (P12,872,180.00)”

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 444, S-2022-25 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The City Development Council of Urdaneta, Pangasinan has identified items in their Supplemental Annual Investment Program No. 1. This was endorsed to the Sangguniang Panlungsod for approval on January 15, 2024 by the City Development Council through Resolution No. 01-2024 and was favorably acted upon by the Sangguniang Panlungsod on January 30, 2024 through Resolution No. 444, Series of 2022-25;

2. The SAIP covers fund augmentation for the Maintenance and Other Operating Expenses (MOOE) and capital outlay of some city offices and implementation of development projects of the LGU. Proposed to be funded from their loan proceeds from the Development Bank of the Philippines; and
3. Funding support for the full implementation of the same in the amount of Php 12,872,180.00 is embodied in their Supplemental Budget No.1 for CY 2024 which was enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 53, Series of 2022-25 on January 30, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Urdaneta, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


