RESOLUTION NO. 940-2024

APPROVING RESOLUTION NO. 573, S-2022-25 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 4 OF THE CITY OF URDANETA FOR CY 2024 IN THE AMOUNT OF FOURTEEN MILLION FOUR HUNDRED SIX THOUSAND FIVE HUNDRED SIXTY-FIVE PESOS ONLY (P14,406,565.00)"

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 573, S-2022-25 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The City Development Council of Urdaneta, Pangasinan has identified items in their Supplemental Annual Investment Program No.4. This was endorsed to the Sangguniang Panlungsod for approval on June 10, 2024 by the City Development Council-Executive Committee thru Resolution No.04-2024 and was favorably acted upon by the Sangguniang Panlungsod on July 17, 2024 through Resolution No. 573, Series of 2022-25;
- 2. The SAIP covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses (MOOE) and capital outlay of some city offices; and

3. Funding support for the full implementation of the same in the amount of Php 14,406,565.00 is embodied in their Supplemental Budget No.4 for CY 2024 which was enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 69, Series of 2022-25 on July 17, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Urdaneta, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 573, S-2022-25 of the Sangguniang Panlungsod of Urdaneta, Pangasinan, entitled "Approving Supplemental Investment Program (SIP) No. 4 of the City of Urdaneta for CY 2024 in the amount of fourteen million four hundred six thousand five hundred sixty-five pesos only (P14,406,565.00)";
