APPROVING RESOLUTION NO. 32, S-2024 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2, S. 2024 OF THE SUPPLEMENTAL BUDGET NO. 2, S. 2024 OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 32, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Local Development Council of San Quintin, Pangasinan has formulated and adopted the municipality’s Supplemental Investment Program No. 2 thru MDC Execom Resolution No. 3, S. 2024 dated July 12, 2024 and endorsed the same to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on August 19, 2024 through Resolution No. 32, S.2024. This is in pursuance to Sections 106, 109, 114 of the Local Government Code of 1991;
2. The Supplemental Investment Program No. 2 with an investment requirement amounting to Php6,039,783.46 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of various offices in the LGU; and

3. The Sangguniang Bayan enacted Supplemental Budget No. 2 for Calendar Year 2024 through Appropriation Ordinance No. 3, S.2024 dated August 19, 2024 to support the full implementation of the Supplemental Investment Program No. 02 of LGU San Quintin.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Quintin, Pangasinan;


