RESOLUTION NO. 947-2024

DECLARING ORDINANCE NO. 14, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING VARIOUS PLANTILLA POSITIONS IN THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT OF INFANTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 14, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee and Human Resource Management and Development Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447(a)(1)(viii) of the Republic Act No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 14, S-2024 of the Sangguniang Bayan of Infanta, Pangasinan, entitled "An ordinance creating various plantilla positions in the different offices of the Local Government of Infanta, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
