**APPROVING RESOLUTION NO. 403, S-2024 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 3 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) THRU RESOLUTION NO. 002, SERIES OF 2023 AMOUNTING TO SIX HUNDRED THOUSAND PESOS (P600,000.00)”**

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 403, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Bayambang, Pangasinan prepared the LGU's Supplemental Annual Investment Program No. 3 for CY 2023 as an attachment to MDC Resolution No. 002, Series of 2023 dated April 18, 2023. This was approved and endorsed by the Council to the Sangguniang Bayan for approval;
2. The Sangguniang Bayan approved said Supplemental AIP through Sangguniang Bayan Resolution No. 403, Series of 2024 dated August 28, 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;

3. The Supplemental AIP covers the reprogramming of the project, “Construction of the Multi-Purpose Hall” to “Installation of Solar Street Lights and Rehabilitation/Construction of Drainage System” in the same barangay, Brgy. Zone VI, Bayambang;
4. The new/proposed projects to be funded from the reversion of a sum of P600,000.00 from the 20% Development Fund (CY 2023 Continuing Appropriation) conform with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
5. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 03, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04, Series of 2024 dated August 28, 2024; and
6. The said SIP No. 3 also includes the change of location of the following projects which were included in the previously approved AIP 2023 of the LGU, to wit: (1) Installation of (Solar) Streetlights from Brgy. Buayen to Brgy. Zone III and (2) Construction of Outpost from Brgy. Buayen to Brgy, Mangayao, same municipality and with no changes in the project cost and fund source.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was–

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 403, S-2024 of the Sangguniang Bayan of Bayambang, Pangasinan, entitled “Approving the Supplemental Annual Investment Program No. 3 duly indorsed by the Municipal Development Council (MDC) through Resolution No. 002, Series of 2023 amounting to Six Hundred Thousand Pesos (P600,000.00)”;


