**APPROVING RESOLUTION NO. 404, S-2024 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 4 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) THRU RESOLUTION NO. 6, SERIES OF 2024 AMOUNTING TO SEVEN MILLION THREE HUNDRED FOUR THOUSAND TWO HUNDRED TWENTY-SIX PESOS (P7,304,226.00)"**

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 404, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Bayambang, Pangasinan prepared the LGU's Supplemental Annual Investment Program No. 4 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 6, Series of 2024 dated May 15, 2024 to the Sangguniang Bayan for approval;
2. The Sangguniang Bayan approved said Supplemental AIP No. 4 through Sangguniang Bayan Resolution No. 404, Series of 2024 dated August 28, 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;

3. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱7,304,226.00, covers the augmentation of funds for the implementation of project, Additional Works for the Construction of Bayambang Central Terminal (Phase I), of the LGU;
4. The project/s proposed to be funded from the reversion of Current Appropriation of the 20% Development Fund (CY 2024), in the amount of ₱7,304,226.00, conforms with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects); and
5. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 04, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 5, Series of 2024 dated August 28, 2024.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


