**PROVINCIAL RESOLUTION NO. 965-2024**

**AUTHORIZING THE PROVINCE OF PANGASINAN TO ESTABLISH/OPEN AN INTEREST-BEARING CURRENT ACCOUNTS WITH THE LAND BANK OF THE PHILIPPINES LINGAYEN BRANCH FOR THE (1) DEVELOPMENT AND LIVELIHOOD FUND (DLF), AND (2) REFORESTATION, WATERSHED MANAGEMENT, HEALTH AND/OR ENVIRONMENT ENHANCEMENT FUND (RWMHEEF) IN CAYANGA, BUGALLON**

**WHEREAS**, on March 11, 2024, Provincial Resolution No. 348-2024 was issued authorizing the Provincial Governor, Ramon V. Guico III, to enter into and sign the Memorandum of Agreement with PV Sinag Power, Inc. and RE Resources, Inc. for the establishment and administration of interest-bearing current accounts for the Development and Livelihood Fund (DLF), And Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF);

**WHEREAS**, by virtue of the above authority, on April 18, 2024, the Provincial Government of Pangasinan and PV Sinag Power, Inc. entered into a Memorandum of Agreement regarding the above subject;

**WHEREAS**, there is a need for the Province of Pangasinan to establish/open an account with the Land Bank of the Philippines Lingayen Branch for the (i) Development and Livelihood Fund (DLF), and (2) Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF) of PV Sinag Power, Inc.;

**WHEREAS**, there is also a need to authorize officials/personnel of the Provincial Government of Pangasinan to sign for and on behalf of provincial government relative to the establishment/opening of (1) Development and Livelihood Fund (DLF), and (2) Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF);




