GUICO III, TO ENTER INTO AND SIGN THE UNITED STATES AGENCY FOR INTERNATIONAL DEVELOPMENT (USAID) TUBERCULOSIS IMPLEMENTATION FRAMEWORK AGREEMENT (TIFA) WITH THE JSI RESEARCH & TRAINING INSTITUTE, INC. FOR THE PROVISION OF TUBERCULOSIS COMMITMENT GRANT #0012-0549-1016 MODIFICATION 1

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is a letter from Dr. Anna Ma. Teresa S. de Guzman, Provincial Health Officer II, dated October 17, 2024, requesting for the passage of a resolution authorizing Governor Ramon V. Guico III to enter into and sign a United States Agency for International Development (USAID) Tuberculosis Implementation Framework Agreement (TIFA) with JSI Research & Training Institute, Inc. for the provision of Tuberculosis Commitment Grant #0012-0549-1016 Modification 1;

**WHEREAS,** the Tuberculosis Implementation Framework Agreement (TIFA) Project is a five-year cooperative agreement funded by the U.S. Agency for International Development (USAID);

WHEREAS, a United States Agency for International Development (USAID) Tuberculosis Implementation Framework Agreement (TIFA) has been entered into by and between the Province of Pangasinan and JSI Research & Training Institute, Inc. which was executed on September 27, 2023;

**WHEREAS,** both Parties have also signed an acknowledgment receipt and acceptance of the Tuberculosis Commitment Grant #0012-0549-1016; however, there are modifications that need to be supplied to the existing commitment grant;

**WHEREAS,** the Tuberculosis Commitment Grant #0012-0549-1016 Modification 1 provides the following:

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (b) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

WHEREAS, for the above purpose, the Agreement shall be entered into and signed by the Province of Pangasinan, represented by Honorable Governor, Ramon V. Guico III; with the JSI Research & Training Institute, Inc., represented by Mr. Tien Ngo, Senior Agreements Management Officer, TIFA;

WHEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was -
