### RESOLUTION NO. 976-2024

**APPROVING RESOLUTION NO. 289, S-2024 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 FOR CY 2024 OF THE MUNICIPALITY OF BINMALEY, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 289, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Binmaley, Pangasinan prepared their Supplemental Investment Program (SIP) No. 3 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 3, Series of 2024 dated August 22, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental AIP, which has a total investment requirement of ₱8,710,001.32, covers the augmentation of funds for Personal Services (Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Executive Order No. 64 S. 2024) and Maintenance and Other Operating Expenses of the LGU; and

4. Funding for the SIP is embodied in their Supplemental Budget No. 2 for FY 2024, which was enacted by the LGU's Sangguniang Bayan through Appropriation Ordinance No. 2, Series of 2024 dated August 27, 2024.




