**RESOLUTION NO. 978-2024**

**DECLARING ORDINANCE NO. 089-2024 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SECTION 4 (A) (1) (E, F AND G) OF ORDINANCE NO. 081-2023, ENTITLED “AN ORDINANCE CREATING VARIOUS OFFICES AND PLANTILLA POSITIONS IN THE EXECUTIVE DEPARTMENT OF THE MUNICIPAL GOVERNMENT OF LABRADOR, DEFINING THE DUTIES AND RESPONSIBILITIES AND PROVIDING THE NECESSARY FUNDS THEREOF AND ABOLISHING THE PLANTILLA POSITIONS OF ADMINISTRATIVE OFFICER V AND MANPOWER DEVELOPMENT OFFICER I” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 089-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Human Resource Management and Development Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76, 78, and 447 (a) (1) & (viii) of R.A. No. 7160 and Civil Service Commission Memorandum Circular No. 20, S-2019 re: Qualification Standard for the Public Employment Services Office(PESO) positions in the Local Government Unit pursuant to R.A. No. 8759, as amended by R.A. No. 10691;


