**APPROVING RESOLUTION NO. 418, S-2024 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN, UNDER MDC RESOLUTION NO. 5, S. OF 2024 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 2 CY 2024 AMOUNTING TO FOUR MILLION SEVEN HUNDRED SEVENTY FIVE THOUSAND EIGHT HUNDRED EIGHTY SIX PESOS AND 46/100 (P4,775,886.46)”**

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 418, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code of 1991. The Municipal Development Council of Bautista, Pangasinan has identified items in their Supplemental Annual Investment Program No. 5. This was endorsed to the Sangguniang Bayan for approval on August 3, 2024 by the Municipal Development Council-Executive Committee through Resolution No. 5, S. of 2024;

2. The SAIP covers fund augmentation for the Personal Services (implementation of the First Tranche Salary Adjustment to all municipal officials and employees), and MOOE of some municipal offices of the LGU; and
3. Funding support for the full implementation of the same in the amount of Php 4,775,886.46 is embodied in their Supplemental Budget No.2 for CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2 S. of 2024 on August 5, 2024.


